Discussed the following:

- We need to meet with our departmental P& T Committee to make sure the process is clear. Be certain the dossiers are in the correct order.
- Dr. Hull Is forming a committee to build a summer course funding model soon. Want to make it profitable, develop a model that will attract a lot of students and will allow some to go back to the department. Catch-up courses and courses for adults may work well.

Addressed the following questions:

1) Can we offer supersections?

- It will be in the mix. We tried last year, but the two offered last summer didn't make (had less than 100).
- 2) What is the status of the BOR prospectus for new majors? They [BOR] are very bogged down, but they are slowly studying the proposals.
- 3) When can we advertise for replacement positions?
 We are purposely being slow. We are expecting another 2% budget cut. We are going through them. It shouldn't be too much longer. If there is a problem, you should know within a couple of weeks.

V. Dr. Alfred Fuciarelli – Asst. VP for Research / Dean Graduate School Discussed the following:

- Is collecting a list of scholarly publications from July 1, 2011 to June 30, 2012 for the Valdosta Scholar. Send the list to your respective Dean.
- The University P&T Policies and Procedures have been revised to include lecturers, senior lecturers, and instructors. The Faculty Senate approved it May 17, 2012 to be effective Fall 2013. The revised document will be posted soon on the VPAA web site.
- Is working with Dr. Sanjay Gupta of the College of Business Administration along with Digital Measures to have the Graduate Faculty status application easily generated.
