2015-2016 Annual Report of the Faculty Senate By Dr. Peggy L. Moch

The 2015-2016 academic year began with Dr. Cecil Staton becoming the Interim President of VSU and ended with him taking a position at another university outside of the USG. Dr. Staton was given a directive from USG Chancellor Huckaby for the reduction of faculty at VSU due to a five year reduced enrollment trend. Thirty individuals received letters of non-renewal including staff, temporary faculty and tenure line faculty. No tenured faculty received letters. Determinations for the reduction of faculty were based on the number of credit hours generated by departments, not contact hours. Decisions for which personnel were to receive letters were made by Department Heads and their respective Deans based on the guidelines received from USG attorneys for this purpose. Letters were then dispersed from the Deans' offices. On January 28th, 2016 the faculty senate passed a resolution of support for the faculty and staff receiving letters of non-renewal which was forwarded to Dr. Staton on February 2nd, 2016. Letters of explanation for use by those receiving letters and other assistance were posted to the Faculty Senate webpage under "Faculty Support" as stated in the resolution.

On July 1, 2015, Dr. James Archibald became the Interim Vice President for Student Affairs and thereby had to resign as President of the Faculty Senate (FS). Dr. Peggy Moch the VP/PE was made President of the FS per the bylaws following Dr. Archibald's resignation. Dr. Bonni Cohen, accepted the position of Interim Assistant Dean of the College of Nursing and Health Sciences and likewise resigned as Secretary of the FS. Vacancies were announced at the August 2015 meeting of the FS and elections were held at the September 2015 meeting with Mr. Michael Holt being elected as VP/PE and Dr. Sudip Chakraborty being elected Secretary. At this time, it was discovered that elections had not been held in spring 2015 for a third of the FS and a third of the statutory committee seats, nor had a third of the standing committee seats been assigned. The Chair of the Committee on Committees (CoCo) was notified and in conjunction with the FS President, Dr. Moch, Deans were notified of the need for elections. Dr. Moch would like to commend and thank Ms. Kalina Winska, the CoCo Chair, for her diligence and dedicated service in completing the work of her committee in a timely manner throughout the academic year.

Discussion continued and a document was sent forward for the January FS meeting agenda.
- Summer 2016 scheduling issues remanded to the Academic Scheduling and Procedures Committee; An electronic vote was taken due to the time sensitive nature of this issue so the results could be given to the Registrar in a timelier fashion.
- Student Athlete of the Semester Recognition Program remanded to Athletic Committee previously and voted on at this meeting. The senate approved the program.

January 2016

- An amended version of a resolution of support for the faculty and staff receiving letters of nonrenewal was passed by the FS and sent forward to President Staton.
