### Minutes of February 16, 2006

**The Valdosta State University Faculty Senate meeting convened at 3:30 p.m. in the University Center Magnolia Room**

R. Zaccari called the meeting to order and informed the Faculty Senate of the following:

- ◆ On February 20<sup>th</sup> R. Zaccari and others from VSU will travel to Atlanta to interview the four finalists for the pre-planning of the new Health Sciences and Business Administration Center.
- ◆ The planning process is continuing on the next phase of new student housing, which will be located on North Campus. R. Zaccari is optimistic that VSU can break ground on this new 600-bed facility in December, 2006.
- ◆ On February 23<sup>rd</sup> R. Zaccari and others from VSU will travel to Atlanta to make the FY 2007 budget presentation to the Board of Regents. VSU is requesting increases in the following fees: Technology; Parking and Transportation; Student Health; and Athletic.
- ◆ The planning process is continuing on the new Student Union and VSU hopes to secure an architect for this project in the near future.
- ◆ On February 28<sup>th</sup> R. Zaccari and others from VSU will meet with Lord, Aeck & Sargent, the planning and architectural firm selected to complete VSU's first Campus Historic Preservation Plan (CHPP). As part of this study the traffic flow in the vicinity of VSU, including the VSU bus routes, will be reviewed. Additionally, the parking structure at VSU will be reviewed and possible areas for location of a new parking facility will be determined.
- ◆ A ribbon cutting will be held during the first week of April for the pedestrian mall. The formal dedication of the Hugh C. Bailey Science Center will also be held during the month of April.
- ◆ A major gift has been given to Valdosta State University by the James L. Dewar family and Park Avenue Bank. The \$2 million gift has been endowed to the VSU College of Education.
- ◆ R. Zaccari was very pleased with the Presidents lecture series. The lecture series will increase to a total of four presentations during the next fiscal year.

R. Zaccari turned the meeting over to D. Boyd. D. Boyd read the list of proxies.

### 3. New business

a. Report from the Academic Committee – Louis Levy

L. Levy thanked R. Zaccari and all those involved with the inaugural lecture series. This year programs in the College of Business Administration, Biology, and General Studies are undergoing program review. Next year General Education will be undergoing program review and that will be a time for everyone to reflect on the program at VSU. There is particular interest in Area B. The Faculty Evaluation Task Force is continuing to review student evaluations of classes. The Faculty Handbook is being revised and will be available online by late summer. The Academic Committee recently approved the Doctorate of Public Administration proposal and the proposal is now awaiting review by the Board of Regents.

A motion was made and seconded to accept the minutes from the Academic Committee. The motion was approved.

#### 4. Old Business

Lee, and the Judicial Committee will meet to assess plagiarism issues and create a centralized list regarding disciplinary actions.
- ◆ Update on considering charging an E-rate to Distance Learning students (Technology Committee) – Past Chair Lorraine Schmertzling indicated the Technology Committee has not met this year and therefore an update on this issue could not be provided.
- ◆ Update on changing “handicapped” to “Persons with Disability” on several documents (Minority and Diversity Issues Committee) (**This item was approved at the November 17, 2005 Faculty Senate meeting.**)
- ◆ Report from the Nominating Committee – M. Noll reminded everyone that nominations for the position of Executive Secretary are due by the next Faculty Senate meeting (March 23, 2006). The election of the Executive Secretary will be held during the March 23<sup>rd</sup> meeting.
- ◆ Faculty Senate agreed to move the March Faculty Senate meeting from March 16 to March 23<sup>rd</sup> due to the fact that VSU’s spring break is scheduled for March 13 – 17.

#### 5. General Discussion

- ◆ M. Noll reported that the Strategic Communication Task Force will give a report at the March Faculty Senate meeting.
- ◆ L. Bell expressed concern that some VSU students are not knowledgeable about plagiarism. M. Schmidt informed the Senate that there will be continued dialogue on this subject prior to presenting a policy for approval. - ◆ M. Noll informed the Senate that he gives extra credit to students for regular class attendance. However, the infirmary does not give a note/excuse to students who went to the infirmary and had to miss class because they were ill. E. Nielsen stated that although the infirmary will not issue any paperwork regarding the students they will confirm, via telephone, if a student has visited the infirmary.

(Review of the Reporting Forms will minimize the chances that an Issue/Topic remanded by the Faculty Senate will linger unresolved, and ensure that all committees have submitted a report.)
3. Each Standing and Sub-committee chair will present its Annual Report to the Faculty Senate during the last meeting of the academic year. The Faculty Senate will vote to maintain, dissolve, or remand to the Committee on Committees for review and recommendation, any inactive committees.

4. Approved Reporting Forms will be posted and archived on the Senate webpage.

Senator Wilson Huang suggests the following concerning the Equal Opportunity Statement:

Ask University Attorney to review the statement clauses “Title VI of the Civil Rights Act of 1964” and “Title IX in Section 504 of the Rehabilitation Act of 1973”. He suggests that protections clauses for equal opportunity are stated in “Title VII of the Civil Rights Act of 1964” and in “Title V” of the Rehabilitation Act.

He further suggests that when the statement is revised that legal citations be removed because it is difficult to track pertinent legislative amendments and the statement becomes outdated.
