Minutes November 19, 2009

The Valdosta State University Faculty Senate meeting convened at 3:40 p.m. in the Magnolia Room

- Call to Order by Dr. Patrick J. Schloss:
- Discussed the November 18th BOR meeting. There is a certainty for an 8% budget reduction, maybe 10%. No adjustments to our budget will be needed, since plans had been made for the reduction. There will be an additional \$100 student fee for Spring semester. Summer budget should remain intact.
- Discussed Dr. Levy's retirement. Jay Rickman will chair the search committee for a new Provost/Vice President for Academic Affairs. A search firm will not be used.
- Introduced Mr. Stanley Jones as new Registrar.
- Introduced Dr. Phil Gunter as Interim Provost/Vice President for Academic Affairs.

- Jay Rickman presented Dr. Levy with a plaque to recognize his extensive service to the Faculty Senate. Dr. Levy has attended at least 160 Senate and Senate Executive Committee meetings throughout his career at VSU.

1. Announced formation of a Senate Nominations Committee. As required by the *Senate Bylaws* (Article I, Section 3), the Executive Secretary has appointed a committee to garner candidates to stand for election as the Senate’s 2010-2011 Executive Secretary. Senators Peggy Moch [plmoch@valdosta.edu], Nancy Scheetz [nascheet@valdosta.edu] and Diane Holliman [dhollim@valdosta.edu] have graciously agreed to serve on this committee, and Dr. Peggy Moch has agreed to chair the committee. The election will be held at the Senate’s March 25, 2010 meeting. Please contact a member of the committee if you are willing to stand for election. [Note: Jay Rickman cannot serve as Executive Secretary for 2010-2011 b/c the *Statutes* (Chapter 4, Article III, Section 3) prohibit a Senator from serving more than two consecutive years in the position of Executive Secretary.]

2. See Attachment B regarding a proposal from Dr. Sheri Gravett for Senate reconsideration of VSU’s “30 year rule” for undergraduate courses. Dr. Gravett notes that this rule is not required by either SACS or the BOR, and that VSU often receives requests to waive this requirement as older adults (i.e., non-traditional students) return to college to complete degrees begun when the student first graduated from high school. *Remanded to Educational Policies Committee for review.*

3. See Attachment C regarding a proposal from Dr. Richard Carter regarding whether VSU should return to an official “Advising Week” prior to the start of pre-registration or whether an “Advising Month” makes more sense for departments with Designated Advisors. *Remanded to Educational Policies Committee for review.*

4. Discussed with the Senate the preliminary planning on the search process for a new Provost/Vice President for Academic Affairs. Executive Secretary Rickman has

been asked by President Schloss to chair a committee that will conduct a national search to fill this post. See Attachment D – Jay Rickman’s email regarding the search process.

Jay,

At its meeting yesterday, the Deans Council discussed the current "30-year rule" for undergraduate courses and recommended that it be referred to Faculty Senate for further consideration. That rule is as follows:

GRADUATION REQUIREMENTS FOR UNDERGRADUATES (pg. 79 of 2009-2010 Undergraduate catalogue):

No degree credit at Valdosta State University can be granted for work completed 30 years before the date of request for evaluation of credits for graduation. Credit for work in some programs older than six years in advance of an expected date of graduation may be invalidated.

This rule is not required by SACS or BOR; however, it has been in effect at VSU for over twenty-five years. Requests to waive this requirement occur each year, particularly as adults return to school to complete degrees that they had been unable to finish when they first enrolled in college. Should this requirement be reconsidered or redefined?

Dear All,

I like Stanley's idea below, however, as a better solution. In the History Dept, we moved to "Designated Advisors" a few years ago and we do advising the month before the start of pre-registration. We announce this through class announcements, postings, and emails to our majors from their Designated Advisor. I am a Designated Advisor, and there is no way I could hold 30 minutes meetings w/ all of my advisees (around 110) during one week when I am still teaching, etc. In departments w/o Designated Advisors, then an Advising Week probably still makes sense. Perhaps, Stanley's email should encourage students to investigate whether their major does advising during one week or in the month prior to the start of pre-registration. Louis could also encourage Department Heads via the Department Heads Council to tell their faculty to announce advising (either an Advising Week or an Advising Month depending on the department) in their classes.

Louis,

In past, the institution has designated a week for faculty to advise students about their course schedules for the following semester - this well in advance of early registration. This was very sound practice, in that it provided a standard time-frame for all - students, faculty and administration. Under this system, faculty, administrators, and staff could easily remind students - as I often did in class - to see their advisors and to take advantage of their advice during advising week, and notices were conspicuously posted about campus apprising students of advising week.

Everybody was on the same page. Obviously, we can't expect to notify students of the availability of advisement and to advise them effectively and in a timely manner, if we don't have a system that clearly establishes a time frame for advising that is well in advance of the early registration period. I fear we are asking for chaos by not adhering to this time-honored standard.

If VSU does still have a standard advising week, then I respectfully request that it be enforced by the administration.

If VSU does not still recognize a standard advising week, then I respectfully request that we consider re-establishing that time-honored custom, for the reasons cited above.

Vacancy Announcement:

Valdosta State University seeks applications and nominations for the position of Provost and Vice President for Academic Affairs (VPAA). In his first two years as President of the 12,000 student Master's I institution, Patrick J. Schloss has initiated a comprehensive review of the institution's academic and administrative focus. Specific attention has been given to shared governance and enhanced efficiencies. Initial activities have included redirection of funds to academic priorities such as: graduate student support, faculty reassigned time, academic and scientific equipment, and instructional/research infrastructure. Early achievements have included an 8% enrollment increase, expanded research productivity, and stronger civic engagement. Aside from responsibilities typical of a Provost and Chief Academic Officer, the successful candidate will partner in this change.

One of two regional universities in the University System of Georgia, VSU is located in Valdosta, Georgia, a metropolitan area along the Florida-Georgia border in south central Georgia. The campus is noted for its Spanish mission architecture and natural beauty.

Required Qualifications

Terminal degree from a regionally accredited university; rank of professor or equivalent with a distinguished record of scholarship; increasingly complex administrative appointments, including the management of a complex academic unit, comparable to the college of a Master's I or higher institution; demonstrated commitment to cultural diversity and affirmative action.

Desirable Qualifications

The successful candidate is expected to have: advanced the mission of a comprehensive Master's university within a state system of higher education; established a strong record of teaching, research, and service; been effective in engaging diverse constituencies; a demonstrated reputation for integrity and collegiality; taken bold action reflecting an empirical orientation to innovation; experience with technology planning and infusion; and been effective in building consensus, communicating change, overcoming resistance, and evaluating the impact of change.

Application/Nomination Procedures: All applications or expressions of interest will be handled confidentially until a list of individuals to be invited for interviews has been identified. Applications should consist of an academic résumé, application form (http://www.valdosta.edu/academic/documents/Faculty_Employment_APP.pdf), and the names, addresses (including e-mail addresses), and telephone numbers of four references. References will not be contacted without prior approval of the candidate. While applications will be accepted until a successful candidate has been identified, interested parties are encouraged to submit their materials by February 1, 2010, to receive full consideration. The preferred date of appointment is July 1, 2010.
