**SECTION I. Eligibility.**

---

Open to all Artists living in the USA over the age of 18. Works may be in any medium, traditional or experimental. All works must be original, suitably presented, ready to exhibit, completed in the last two years, and not previously exhibited in the Valdosta State University Fine Arts Gallery. Each artist may submit up to three entries. Slides or jpg must accurately represent artwork. Artwork not matching slide or jpg will not be exhibited. NO SUBSTITUTIONS ALLOWED.

**SECTION III. Entry Format: Jpegs or Slides.**

---

Digital images may be submitted on a CD only in jpg. format. Images should not be larger than 2.5 megabytes (MB). Image print size should be no larger than 7 inches in any direction at 300dpi. Label the CD with your name and the files as follows: artist last name and first initial plus entry number of the piece. For instance, artist is Jane Doe: DoeJ1.jpg, DoeJ2.jpg, DoeJ3.jpg. Submit 35mm slides in standard 2"x 2" plastic or paper mounts. Label all slides clearly with name of artist, size (H x W x D), media, year and title. Place red dot in lower left corner of image. Slides of accepted works become the property of VSU for educational & promotional purposes. (Other slides will be returned in the self addressed stamped envelope.)

**SECTION IV. Exhibition.**

---

The exhibition will open January 19 and continue through February 5, 2010. All accepted works must remain in the VSU Gallery until the close of the exhibition.
