Primary Outcomes:

Dr. Pate welcomed everyone and introductions were made. Purpose of meeting was stated.

Dr. Pate advised that in 2008 the Master's in Leadership was discontinued and the Specialist in place to comply with new standards. Now in 2014, in light of proposed GaPSC rule changes, the Master's is being reinstated. We are fortunate to only need to tweak the previous program to comply with PSC rules.

Dr. Bochenko presented a PowerPoint outlining changes for current requirements:

There will be a Tier 1 for entry level leadership positions and Tier 2 for advanced positions (similar to PL6 & PL7); with 250 clinical practice hours for Tier 1 and 750 hours for Tier 2. Also, Superintendent Assurance is not needed for Tier 1. There will be a new test score requirement on the GACE Ethics Leadership Assessment. A writing sample will also be required for admission to the VSU program. GPA requirement of 3.0. Programs of study for Tier 1 & Tier 2 reviewed. Anticipate new candidate enrollment in Summer 2016 and probably a combining of Building and System Level certification. Also, foresee changes developing in the VSU Doctoral Leadership Program as a result.

Questions:

Will Tier 1 classes all be on line? Yes.

If someone completes Tier 1 and a few years later decides to return to the classroom, what happens to salary? Salary will probably return to teaching salary.

Will they come to present program to local boards/etc? Sure.

What about those that are EDL Building level only? PSC will need to review their certification after proposed changes are made.

This change will benefit us, in that – everyone will have to offer the same thing (both levels), we will remain competitive, and not have to worry about other programs offered (fly-by-nights) that are not PSC compliant.

Dr. Bochenko to send PowerPoint and P.O.S. to Advisory Council Members.

Present program to local boards and solicit feedback.

Market revised program.
