Catalogue Description:

Prerequisite: ART 1010. A continuation of Drawing I. Further development of drawing techniques and methods for a personal and experimental approach. Abstract imagery, non-representational and representational imagery will be explored.

Text: (Required) Drawing: Space, Form, and Expression by Wayne Enstice and Melody Peters.

SELECTED STANDARDS, GOALS, OBJECTIVES and/or EDUCATIONAL OUTCOMES

- 1. Students will express themselves clearly, logically, and precisely in writing and in speaking and they will demonstrate competence in reading and listening
- 2. Students will demonstrate the ability to analyze, to evaluate, and to make inferences from oral, written, and visual materials.
- 3. Students will use appropriate studio practices including hygiene, safety, and studio policies.
- 4. Students will show an understanding of basic design principles, concepts, media, and formats.

The ability to place the organization of design elements and the effective use of drawing media in aesthetic and design problems should continue throughout the degree program.

- 5. Understanding of the possibilities and limitations of the drawing medium.
- 6. Students will demonstrate an exploration of the many possibilities for innovative imagery and the manipulation of techniques available to the draftsman.

SELECTED ASSESSMENTS and/or EVALUATIONS: Methods of evaluation may include:
