## **COURSE DESCRIPTION**

An orientation and seminar course designed for first-year students and first-semester transfer students. Course includes presentations of issues of student responsibility, personal, social, academic, and musical growth.

- Complete a series of brief quizzes based on reading assignments from the text book. (No. 1, No. 4)
- Write and submit an autobiography of past musical experiences commenting on the reasons for choosing music as a major. (No. 2, No. 8)
- Attend a student or faculty recital; write and submit a review using the guidelines provided by the instructor. (No. 4, No. 5, No. 8)
- Attend a concert of the Valdosta Symphony Orchestra; write and submit a review using the guidelines provided by the instructor. (No. 4, No. 5, No. 8)

### Student Opinion of Instruction (SOI):

At the end of the term, all students will be expected to complete an online Student Opinion of Instruction survey (SOI) that will be available on BANNER. Students will receive an email notification through their VSU email address when the SOI is available (generally at least one week before the end of the term). SOI responses are anonymous to instructors/administrators. Instructors will be able to view only a summary of all responses two weeks after they have submitted final grades. While instructors will not be able to view individual responses or to access any of the data until after final grade submission, they will be able to see which students have or have not completed their SOIs, and student compliance may be considered in the determination of the final course grade. These compliance and non-compliance reports will not be available once instructors are able to access the results. # **CLASSROOM POLICIES**

<u>Attendance and Tardiness</u>: Attendance is required and is expected for all freshman and first-semester transfer students. This course conforms to the official VSU policy as stated in the VSU Catalogue:
