CATALOGUE DESCRIPTION: The second of a two-semester sequence of courses designed to develop the basic keyboard skills essential to music study.

COURSE FORMAT: This class meets for two fifty-minute periods each week for one credit hour.

RATIONALE: A functional knowledge of the piano keyboard is basic to the study of music.

COURSE OBJECTIVES: Upon successful completion of this course, students will be able to:

- 1. Perform elementary keyboard music.
- 2. Improvise simple keyboard accompaniments for given melodies.
- 3. Transpose simple musical works to other keys.
- 4. Play assigned scales and chord progressions at the keyboard.

Meets standards set forth by the National Association of Schools of Music (NASM) for professional degrees in music.

EVALUATION: Course evaluation will be based on the periodic assessment of student keyboard performance. There will be five tests during the semester which will take place in Weeks 3, 6, 9, 12, and 15. Each test will count 20%. Grading: A (90-100) excellent, B (80-89) good, C (70-79) fair, D (60-69) poor, F (below 60) unacceptable.

Students will be evaluated on the following criteria: note reading skills, grasp of musical structure, posture, hand/wrist position, fingering, note accuracy, rhythmic accuracy, musical coherence, ability to maintain minimum required tempo, dynamics, articulations, and pedal usage.

The grade "A" indicates an <u>excellent</u> overall impression and should include:

- fluency in note reading and recognition of harmonic progressions, cadences, and phrase structure;
- ideal posture and hand/wrist position;
- perfect fingering;
- no or negligible mistakes in note and rhythmic accuracy;
- fluency in musical coherence;
- fluent ability to maintain minimum required tempo;
- outstanding accuracy in observing dynamic markings and articulations.
- no or minimal mistakes in pedal usage;

The grade "B" indicates a good overall impression and should include;

- fluency in note reading and recognition of harmonic progressions, cadences and phrase structure;
- almost ideal posture and hand/wrist position;
- almost perfect fingering;
- note and rhythmic accuracy with only occasional mistakes;
- good but not always fluent musical coherence;
- good but not always fluent ability to maintain minimum required tempo;
- good but not totally accurate observation of dynamic markings and articulations.
- minimal mistakes in pedal usage;

The grade "C" indicates a <u>fair</u> overall impression and should include:

- good fluency in note reading and recognition of harmonic progressions, cadences and phrase structure;
- acceptable posture and hand/wrist position;
- acceptable fingering;
- acceptable number of mistakes in note and rhythmic accuracy;
- acceptable musical coherence;
- acceptable ability to maintain minimum required tempo;
- acceptable observation of dynamic markings and articulations;
- acceptable pedal usage;

The grade "D" indicates a <u>poor</u> overall impression and indicates a <u>failing</u> level of performance in some of the above evaluation criteria. The instructor will judge the student's ability to improve based on the student's pattern of behavior.

The grade "F" indicates an <u>unacceptable</u> overall impression and indicates a <u>failing</u> level of performance in most or all of the above criteria.

The instructor will explain and demonstrate thoroughly the grading criteria for the class and with each individual student.
