  - Talking with department heads whose departments offer core curriculum classes at
    Kings Bay about a visit this summer to the Kings Bay campus, possibly in June. A group
    from VSU could go over to Kings Bay to meet faculty, to discuss the core and possible
    assessment activities as well as any other issues of interest.
  - Identifying some faculty members who are using innovative teaching techniques in core curriculum classes who might be willing to present some of their strategies during our scheduled core curriculum meeting on Tuesday, August 9, at 1: 30 p.m. Some possible suggestions included those who are teaching innovative supersections (SOCI 1101) or

pioneering new ways to utilize technology (hybrids in ENGL 2110-2130) or combining different disciplines (one of the PERS courses).

- 4. At our next meeting, we would also like to invite colleagues from the Office of Strategic Research and Analysis to help us draft guidelines for the use of appropriate random sampling for assessments in core curriculum courses.
- 5. The GEC members also agreed to continue our current meeting schedule during the summer (the 4<sup>th</sup> Tuesday of each month at 2 p.m.)
