1. Update on Proposed Learning Outcomes: Sheri Gravett

Passed Faculty Senate on September 16 Submitted to USG General Education Council for October 26 meeting If needed, the USG GEC meets again on December 20

- 3. Implementation and Transfer Issues Related to the new core implementation: GEC and Admissions and Registrar's Offices

Concerns were discussed about the following portion of the new core policy:

"Students successfully completing a course in one institution's Area A-E will receive full credit in Areas A-E for the course upon transfer to another System institution as long as (a) the course is within the Area hours limitations of either the sending institution **OR** receiving institution and (b) the student does not change from a non-science major to a science major."

"Students who transfer after having completed the US/GL/CT requirements of sending institution may not be required to complete the US/GL/CT requirements of the receiving institution. Students who transfer after having completed Areas A-E but without having completed the US/GL/CT requirements must complete the US/GL/CT requirements at the receiving institution."

Questions were raised about several issues:

- (1) How to place courses from USG institutions that will have differing hour requirements in core areas;
- (2) How to indicate whether students have met the overlay requirements and how that information will be correctly and effectively communicated to advisors and students;
- (3) How should VSU treat these overlays if students have met the course requirement from the transfer institution but that institution did not have the overlay located in that course (i.e., the critical thinking requirement will be in VSU's Area A, but how will we judge that requirement if a student took ENGL 1101, ENGL 1102, and MATH at another institution but the critical thinking requirement was in another area that the student did not complete?)

In preparation for these changes, this group made several recommendations:

- (1) Designate and train transfer advisors in the various advising centers and in departments. These advisors could assist their colleagues with transfer advising issues.
- (2) Urge the USG to post the new approved core curriculums for all institutions as soon as they are approved. The BOR website currently has a page with links to core curriculum requirements at all USG institutions at http://www.usg.edu/academic programs/information/core curriculum requirements for usg colleges and universities/ It would be helpful to post both the old and the new cores so Admissions and Registrars' Offices throughout the system could begin preparations.
- 4. Discussion of Current Assessment Data: GEC Once VSU does have new learning outcomes and overlays in place, the GEC will need to plan future workshops to assist those faculty teams who are already collecting assessment data. However, the GEC should also take time to look at the assessments so far and the data produced to make recommendations: do these assessments appear to be measuring the stated outcomes? Are the results following clearly from the outcomes? Is the data going to be usable in suggesting curricular or pedagogical changes? How will the assessments need to be revised in light of the proposed learning

Each member of the GEC agreed to review the results below for our next meeting and provide a report, either written or oral with recommendations for the assessment teams. Those items in **bold** are not currently being assessed, but assessments will need to be developed as part of our proposed new overlays:
