Description

An examination of the functions of the library within the higher education environment. The course promotes the Jeffersonian ideal of the library as the center of the university and explores administrative issues and service patterns specific to the academic library.

Note: This is a writing intensive course

Outcomes

Students will

1. Discuss the history, development, and role of the academic library
2. Identify the issues facing academic libraries in the current higher education environment
3. Describe characteristics of the administrative departments in academic libraries
4. Explain the principles of service unique to the academic library
5. Apply the current standards and guidelines used to assess academic libraries in higher education
6. Write for a scholarly audience about topics specific to the academic library using LIS literature
