Ms. Maggie Viverette with the Minority Affairs Office spoke about the Cultural Diversity Audit for VSU. This audit will consist of telephone surveys, online surveys and focus groups to obtain information from students, staff, and faculty concerning diversity campus wide. Ms. Viverette encouraged COSA members to participate and to help encourage a campus wide response by completing a survey or participate in an interview or focus group. The results of the audit will be used to identify important diversity issues at VSU and will serve as a benchmark for years to come. The Diversity Cultural Audit, a part of VSU's Strategic Plan, will begin in November. Surveys and interviews will remain anonymous and honest answers are requested.
