



## **COUNCIL ON STAFF AFFAIRS**

### **Minutes of Tuesday, August 20, 2013**

#### **1) Call to order**

a) Chair Regina Lee called the meeting to order at 9:02 AM in the UC Cypress Room.

#### **3) SPECIAL ORDER OF THE DAY**

a) Vicki Pennington of Valdosta Women's Voices introduced Kathryn Grant to speak about her organization, The Campaign to Keep Guns Off Campus, and the current bill, SB 101, that is up again for a vote in January 2014 when the State legislature is back in session. SB 101 will, among other things, allow guns on public college campuses. The USG has publically come out against this bill. The bill narrowly passed last spring and when it comes up for a vote in January, it has more than a 50% chance of passing. Kathryn explained that her organization is working to educate people about this bill, collects signatures on petitions, and encourages people to write, call, email their state legislators to ensure the voices in Valdosta are heard on the issue and this bill is stopped. Kathryn asked for support from members of COSA. There will be a "Day of Action" event on Saturday, October 5 on campus - volunteers will hand out flyers, gather signatures on petitions, and education people about this issue and what they can do to stop SB 101.

b) Dr. McKinney talked about the gun legislation and the unified effort of the USG to stop SB 101. He also discussed some of the changes to Homecoming Week and the expansion of VSU's mission to serve the entire state of Georgia and beyond. VSU is no longer a regional university; we are now a comprehensive university. Dr. McKinney continued sharing ideas for creating touchstone events for alums (like spring reunion weekends) and asked the COSA reps to share ideas for engagement of alumni. Heather Proctor provided additional details about Homecoming Week and reminded the group that September 7<sup>th</sup> is the first game. It will be in Macon and a huge tailgate party is planned which will be catered by Fresh Beginnings and a cocktail party also.

#### **4) Approval of the Minutes of July 16, 2013 meeting of the Council on Staff Affairs**

a) A motion was made and seconded to approve the minutes of July 16, 2013. They were approved unanimously.

#### **5) Treasurer's Report – Shanika Hezekiah**

a) State allocation - \$2,082.00; Discretionary - \$1,868.76; Blazer Books - \$1,404.00; Retirement Walkway - \$13,768.33.

#### **6) Communication with Administration**

a) Report from the Chair – Regina Lee

#### **7) Staff Attendance and Participation**

a) Publicity Report - Lisa Snipes

  - 1) In July, 127 citations upheld and 65 dismissed.

It is currently \$100. Three people will be awarded instead of 5, in part to conserve the money in the account.
