1) Call to order

3) Communication with Administration

- a) Dr. Carvajal reported that as was his plan, the leadership team is coming together. The goal is to have the team largely in place (or moving in that direction by the end of fall 2017). Dr. Bob Smith, Provost/VPAA and Dr. Rodney Carr, VPSS are both starting on July 1, 2017. We also recently filled two leadership positions in IT and the Director of Housing and are working on the Chief Legal Affairs and Dean of Student positions currently. After this round, we will focus on the Dean, Department Head and Director positions needing to be filled.
- b) We are looking to make VSU the flagship campus of the USG for our region. We want to see this in two important components.
 - 1) Economically The Georgia Chamber of Commerce has opened its regional office in Tifton and has created a task force to look at economic development for the region. VSU will play an important role in this endeavor.
 - 2) Legislatively VSU hosted the Higher Education committee of the state legislature last week to discuss important issues of concern.
- c) The Advancement staff have been working on our first ever Capital Campaign. It began with a goal of \$42M but this was quickly raised to \$53M. We just received a pledge for \$500G dollars and pledges now total more than \$51M and we are only halfway through the campaign. This year, for the first time, VSU will award more than \$1M in scholarships.


