1) Call to order

3) Communication with Administration

- a) Dr. Carvajal discussed the recent issue with the suspension of former COSM Dean. Dr. Keith Walters and thanked the staff and faculty for our overall response to the situation.
- b) Dr. Carvajal reminded everyone that the Georgia Legislative season is in full swing. There will be both a Comprehensive University and VSU day at the capital soon. Based on his read of things, Dr. Carvajal is optimistic that the university will receive the design funding we requested for Ashley Cinema.
- c) Dr. Carvajal indicated that the Center for South Georgia Regional Impact has been extremely active in representing our region's needs. It is especially focused on ensuring our area is fully represented in the US Census. This will impact representation and funding for the southern part of the state.
- d) Dr. Carvajal indicated that the men's basketball team is currently in 1st place in the Gulf South Conference and 12th place nationally. Congratulations!
- e) Dr. Carvajal announced that our MPA program is currently ranked #1 in the nation. Congratulations!!

4) Special Order of the Day

- a) Dr. LaGary Carter, Interim Dean of CONHS, and Jenni Shinpaugh, Associate Director of Housing discussed the upcoming Diabetes Prevention program being offered by the university. The program is designed for employees who have been diagnosed as pre-diabetes or have a high risk of getting diabetes. There are several USG institutions with a similar program currently. Our program is planned to start in March 2020 and run for one year. For the first 16 weeks, the group would meet weekly either at lunch or immediately after work and for the second 16 weeks, the meetings would be held once or twice a month.
 - 1) The program is not a weight loss program but is more focused on behavior modification strategies including a change in diet and exercise.
 - 2) The plan is to have a cohort of between 15 and 18 participants. If demand is high enough, we would consider offering several cohorts.
 - 3) More information will be sent to all VSU employees very soon via email.
