2021-2022 Annual Report of the Faculty Senate Michele Blankenship, President

The Faculty Senate met eight times during the 2021-2022 academic year. The Executive Committee invited President Carvajal and Provost Smith to all meetings. The minutes reflect their attendance and comments. At each meeting, the statutory committees and standing committees of the Senate were encouraged to give reports. A number of meetings featured presentations by guests. The minutes of each meetings are available on the Faculty Senate website at https://www.valdosta.edu/administration/faculty-senate/minutes.php. A brief summary of Faculty Senate activity can be found below.

August 2021

- New and returning senators were welcomed for the beginning of the academic year.
- Michele Blankenship provided guidelines for online participation in Faculty Senate (FS) meetings and other important reminders for the upcoming year.
- Comments made by President Carvajal included fall enrollment, the COVID-19 situation and reported
 cases, and facility renovations being proposed for funding.
- Comments made by Provost Smith included administration evaluations not abiding by the Board of Regents' (BOR) policies, funding of Faculty Scholarships, and the upcoming search for Dean of the College of Education and Human Services (COEHS).
- Shannon McGee, Associate Vice President for Finance and Administration, reported on the new License Plate Recognition system being used in terms of regulating parking.
- Mike Savoie, Dean of the Honors College, spoke about the proposed revisions to the Promotion and Tenure Guidelines.
- Based on faculty concerns, discussion ensued about the reinstatement of the mask mandate and a
 possible vaccine mandate. Vote was made that the Faculty Senate Executive Committee write a
 resolution to be forwarded to administration.

September 2021

- Comments from President Carvajal included information related to the development of the NPHC Plaza, Strategic Planning, and the Leadership Lowndes program.
- Provost Smith discussed how the University System of Georgia (USG) was proposing a change in the
 Post-Tenure Policy, adjusting the process for evaluating Administrative personnel, the formulation of a
 committee to review replacing the APLnextED system, and the declining COVID-19 infection numbers.
- Sheri Gravett, Associate Provost for Academic Programs and Services, drafted a revision of the Faculty Handbook in which it was remanded to Faculty Affairs Committee to pursue.

October 2021

- President Carvajal provided updates on the third installment of the CVIOG salary adjustment, the Board
 of Regents' approval of honoring Dr. Maggie Viverette, next Budget Advisory Committee meeting, and
 referring students to Hope Connect for socio-emotional and mental health concerns.
- Provost Smith mentioned about the need to revise University Statutes, establishing a task force to visit
 changes in the Post-Tenure Review policy and defining Student Success Activities as a category, and
 declining COVID-19 infection numbers.
- Mitch Lockhart, Chair of Faculty Affairs Committee, offered updates regarding changes to the Promotion and Tenure and Faculty Handbook. Recommendations will be forwarded to the FS Executive Committee.
- Brian Gerber, Chair of Internalization and Globalization Committee, spoke about the idea of offering an International Studies minor on campus.
- Brian Ring gave updates from the USG Faculty Council.

November 2021

- President Carvajal reported on the status of the Budget Advisory Committee's (BAC) review of one-time
 and permanent funding, how redistricting could affect representation of South Georgia in the legislation,
 and upcoming campus events like homecoming and NCAA.
- Provost Smith provided updates on the task forces related to revisions of Post-Tenure and Evaluation of Administrators, and the University Statutes.
- John Crawford from the Division of University Advancement spoke about fundraising campaigns and their importance.
- Jeanine Boddie-La Van from Human Resources spoke about two developments: using ePerformance to submit staff evaluations and developing a telework proposal for Cabinet review.
- Mike Savoie submitted a recommendation for Faculty Senate to approve changes to the Promotion and Tenure Policy that primarily dealt with providing non-tenure track colleagues with a pathway to promotion. Faculty Senated voted to approve the changes.

January 2022

- Remarks from President Carvajal included spring enrollment and retention and strategic planning. He
 also mentioned that Governor would be making two recommendations that could affect VSU: (1) the
 elimination of special institutional fees, but with the state commitment to cover any loss institutions may
 incur from this change, and (2) the implementation of a \$5000 cost of living adjustment (COLA) for all
 state government employees.
- Provost Smith provided updates on COVID-19 matters, the need for retaining students, the COEHS Dean Search, and financial assistance from the state. Provost Smith also gave updates related to the Comprehensive Academic Administrator Evaluation and University Statutes.
- Becky da Cruz, Associate Provost for Graduate Studies and Research, spoke about updating the number
 of transfer hours for Credit for Prior Learning (CPL) to recruit and retain adult learners in specific
 programs.
- Duke Guthrie, Chair of the Diverity and Equity Committee, reported that the committee developed definitions related to Diversity, Equity, and Inclusion Terms for Valdosta State University. The draft was sent to the administration for review.
- In general discussion, Cynthia Tori asked whether changes to the General Core requirements would happen. Provost Smith replied that Tristan Denley's departure from the USG had likely stalled the discussion until a permanent Chancellor was named.

February 2022

- President Carvajal presented updates on the search for the new Chancellor for USG, the work that the Strategic Planning committee had been doing, recommendations being made by the Governor in legislation, and the need to retain students.
- Provost Smith offered updates regarding COVID-19, Post-Tenure Task Force efforts, and the need to review current Academic Suspension Policy. Faculty Senate Executive Committee forwarded the

- Suspension Policy to the Educational Policies Committee for review.
- Hoa Nguyen reported on proposed changes to the anti-discrimination, anti-sexual harassment as well as non-discrimination policies.
- Robbyn DeSpain, Director of Strategic Communications, shared a presentation regarding the Stakeholder Communication Policy and how it works.
- A.J. Rameriz, Chair of Library Affairs Committee, received seven applications for the Library Contingency Funds and all were awarded.
- Lynn Crump, Chair of Technology Committee, reported on the findings gathered from the Technology Survey distributed on campus.
- In general discussion, the topics of the Concerning Behavior Student reports and students parking in Staff/Faculty spaces occurred.

March 2022

- Remarks from President Carvajal included using end-of-year monies to help pay for debt services and support operations in fee-funded areas, receiving the recommended definitions for the Diversity, Equity, and Inclusion policies, and receiving approval from legislation for the cost-of-living adjustment, funding for Farber Hall's renovations, and \$300,000 to develop eDegree programs, particularly in elementary education.
- Provost Smith mentioned that both the Council on Staff Affairs (COSA) and the Student Government Association (SGA) reviewed and provided feedback on the revisions to the University Statutes. A General Faculty Meeting would be called to vote on the revisions. If a quarom did not exist, an electronic vote would occur.
- Sheri Gravett provided updates regarding the Post-Tenure Task Force committee. The VSU Faculty Evaluation Model (FEM) had to be updated to meet BOR policies. Committee was defining "student success" activities and how it fits within the 5-tier evaluation model. Other areas of concern included remediation strategies for the Needs Improvement and Does Not Meet Expectation categories, the appeals process, and the Performance Remediation Plan and Performance Improvement Plan for unsatisfactory annual and post-tenure reviews.
- The Educational Policies committee brought forth a recommendation to revise the Academic Suspension Policy. Faculty Senate approved of the recommended change.
- Nominations for the Senate Executive Committee were called upon.

April 2022

- Melinda Harbaugh reported for President Carvajal and Provist Smith in their absence. She reported on
 the strong support by the legislative body this year to support funding for USG institutions, finalizing the
 Stratigic Plan for the University, and the need for faculty members to connect with students on campus,
 supported by the feedback received from students during the Strategic Planning process.
- Shannon McGee shared a presentation with faculty senate explaining results of the research her office
 conducted related to issues of faculty parking spaces. Based on the data, the parking committee
 recommended: (a) use e-ticketing beginning Summer 2022 as a way to cover more lots, (b) increase the
 fee by \$10 to deter students parking in staff/faculty lots, and (c) use larger lots at entrances to allow more
 time to patrol perimeter lots.
- Sheri Gravett proposed that the revisions to the Faculty Evaluation Model be approved by Faculty Senate. Faculty Senate approved the revisions.
- The Internalization and Globalization committee began updating the minor in Interdisciplinary Studies, including the removal of the Study Abroad requirement. It also advises moving the minor to an academic department. In fall, a program plan for the minor would be developed.
- Elections for the Senate Executive Committee were held.
