4. <u>Updates from President's Office</u>: Dr. Carvajal and/or Dr. Smith

Time of challenge for the USG system and for higher education. News regarding the enrollment concerns, rapid decline in students coupled with the value of a degree. The sector report describes this fall, all 4 sectors are trending down. Our enrollment numbers are still not final but as of this meeting, we are 9.75% down. VSU remains a strong institution, as we have come built in advantages. Bob and I budget conservatively so we are not as dire as some institutions. Next year's budget request is based on a flat budget, not corresponding to the drop in enrolment. In the process of preparing an address regarding the upcoming challenges, be on the lookout for that. We will be sending out an invitation for input on our path ahead as we face some future challenges.

I want to start by thanking all of you for the hard work you all have done over the last 2.5 years. We have some challenges in front of us and some are changing daily. We will need to look closely at everything we do. We need to focus on engaging our students, and I would like to capture the students' excitement of being back on campus. We want to implement our strategic plan and QEP with students. I sent out an email about the FEM. We will be walking away from APL. There is a new model with links in the email.

Questions:

Mitch Lockhart: Any plan to do an autopsy on our old strategic plan what we did well/wrong?

Dr. Smith: No, it is not necessary. VSU has a website that updates where we are regarding the goals in the strategic plan.

Mitch Lockhart: Could you comment on where the source of internal funding came from to make the purchase of the Athletic Field House?

Dr. Carvajal: It was discussed with the Budget Advisory Committee and a case made to the University System Office if there were year-end funds available, using them on our debt would put VSU in a better position from the fee perspective. The year-end funds were used to pay off that project as it was the smallest debt we have, so we were able to pay it off. Then with the agreement of the board we were able to redirect those fees and continue to make payments in a timely fashion for the Student Union.

5. Report from Faculty Senate Executive Committee - Chunlei Liu

• Updates on 2022 senator elections, rosters, and committee assignments

According to the Faculty Senate Bylaws, colleges should hold their committee elections in February. It was discovered in April that many positions were not filled, so elections were still being held in August, and some positions remain not filled, I will work with CoCo to fill openings.

Meeting plan for 2022-2023 academic year

Executive committee voted to hold meetings via Teams for Fall semester and reevaluate meeting format for Spring. The faculty senate meetings are scheduled at 3:30 PM on every third Thursday for each month except during the spring break. The full meeting schedule has been posted on the Faculty Senate website. Review and revision of Faculty Senate and Committee Bylaws-

The Faculty Senate Bylaws were last revised in 2017, and since then our meeting and our election method has changed quite a bit. This year we formed an ad Hoc Committee to review and to revise the bylaws, Ben Harper, the Vice President of the Faculty Senate, will be the Chair of the committee. I hope the committee will review and revise the bylaws this semester and will bring a revised copy for approval in our November meeting.
