Minutes April 16, 2009

The Valdosta State University Faculty Senate meeting convened at 3:33 p.m. in the Powell Hall Auditorium.

- 1. Call to Order by Dr. Patrick J. Schloss
 - There was a moment of silence for those who have been lost recently from the VSU community.
 - Discussed the budget and tuition. The Board of Regents has cancelled the "fixed for four" tuition for new students. The Board of Regents is maintaining the commitment for last year's class ('08-'09). This year's class will have same tuition. All students after this year will be charged on a per credit basis up to 15 hours instead of 12 hours. The \$100 fee established last year has been made permanent subject to annual review.
 - Aggressively working on a new budget model.
 - All temporary positions are being filled.
 - Appreciates the Educational Policies Committee reviewing the cap on the number of credits a student can register for without approval. Dr. Schloss suggested setting a "preference limitation".
 - Discussed academic misconduct cases. Dr. Schloss stated that he is willing to meet with the Educational Policies Committee regarding policies and procedures with these cases.
 - Discussed furloughs. Language will be removed from contracts that would prohibit furloughs.

- 1. Report from Educational Policies Committee Chair Michael Elliott melliott@valdosta.edu. The EPC submits the following to the Senate for consideration. Change the number of credit hours for which a student can register without approval from the current number (19) to 17, at least until we formulate a limited withdrawal policy. Motion was made to reduce the number of credit hours from 19 to 17, with the maximum load for which approval may be given to remain at 21. The language of the policy would also otherwise remain unaltered. (The current policy is delineated on page 42 of the VSU Student Handbook, Volume 2: http://www.valdosta.edu/studentaffairs/documents/SAF_Student_Handbook_08_FINAL.pdf.
 - After extensive debate, consideration was postponed until the May 21, 2009 Faculty Senate meeting. Dr. Levy suggested that the issue should be discussed with Mr. Stanley Jones (Registrar) and the Department Heads Council.
 - 2. President Schloss would like the Senate to review VSU's policies and procedures regarding Academic Dishonesty to determine if VSU should create a faculty committee to hear student complaints when a student is sanctioned because of academic misconduct. Remand to Educational Policies Committee for study during the 2009-2010 academic year, but as soon as possible, the EPC should meet with the President and the Provost to hear their concerns with the current process. The EPC should also consult Dean Russ Mast and Assistant Dean Richard Lee because of their involvement in adjudicating student misconduct issues. The EPC should also consult Dr. James LaPlant,

a former senator who was very involved in the Senate's most recent efforts to revise VSU's Academic Honesty policies and procedures. Dr. Sheri Gravett would be another excellent person for the committee to consult.


3. Presentation on Strategic Focus 2010 by Dr. Kristina Cragg, Assistant to the President for Strategic Research & Analysis, kmcragg@valdosta.edu. Dr. Cragg presented to the Senate the results of the April 3 open forum on the Strategic Focus 2010 Initiative to generate three to five standards for use in the strategic planning process during 2009-2010.

Valdosta State University's revised budget model calls for us to focus clearly on our strategic priorities. In the past budget cycles, we have often distributed a substantial amount of money to wide-ranging, but routine projects (e.g., repairing roofs, procuring instructional technology, enabling transportation). The revised process will remove these routine items (and the typical budgetary support for them) from the strategic funding pool. Instead the appropriate divisions will be expected to establish and efficiently manage these routine projects and their associated funds. Because of the limited amount of funds for (non-routine) strategic priorities, we have identified a preliminary set of standards against which proposals can be evaluated. The standards are those elements that, when achieved, will advance Valdosta State University to an increased position of excellence. Below are the accepted preliminary standards that will be used to develop a rubric for evaluating strategic funding initiatives.
