-Armstrong Atlantic State University- a lot like the model we have now. Have administrators like we currently have, etc.

Please send the following to the executive committee for consideration by the senate.

Proposed Policy:

No faculty member or administrator can be arrested on campus by Public Safety on any criminal charge until the University attorney has been notified.

The University attorney must be present during the interrogation on campus of a faculty member or administrator accused of a serious criminal act on campus. He/she will act as the accused's temporary attorney until that person can find another one.

No faculty member or administrator will be transported to any jail from campus until he/she has been able to call for assistance.

Misdemeanors that include jail time are to be considered "serious criminal acts."

Nothing in this policy prevents the police from subduing an administrator or faculty member in the course of committing a felony or an act threatening the lives of anyone on campus.
