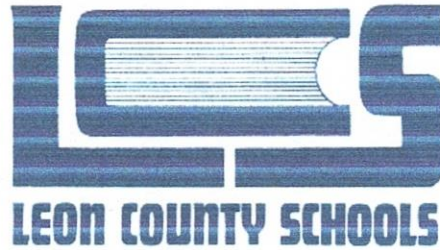

Dear Becky Wetherington,

Valdosta State University has a Field Experience Agreement with Leon County Schools in Tallahassee, Florida which was set to expire on June 30, 2016 unless renewed by the Leon County School Board, according to Section X of the Agreement, which states:

"1. The TERM of this Agreement shall be from the date hereof through June 30, ...and from fiscal year to fiscal year thereafter, upon approval of the Leon County School Board..."

At the last business meeting of the board, the Leon County School Board approved renewal of the Field Experience Agreement with Valdosta State University. Attached is a signed copy of the renewal. This page is to be attached to your current Agreement to document that the Agreement has been renewed and is still current. According to the terms of the Agreement, no approval is needed by Valdosta State University.

Section X also states that *"either Party hereto may terminate this Agreement by giving no less than thirty (30) days prior notice to the other Party."*


