WHEREAS, CCSD and Institution desire to enter into this Renewal Agreement amending the Student Teacher Agreement to provide a (3) year extension of the term of the Student Teacher Agreement;

NOW AND THEREFORE, for and in consideration of the premises and of the mutual covenants contained herein, CCSD and Institution do hereby agree that the Student Teacher Agreement is modified as follows:

1. The foregoing recitals are hereby incorporated herein, and all terms and definitions contained in the Student Teacher Agreement shall have the same meaning herein unless expressly modified.
2. The Student Teacher Agreement is hereby renewed for an additional term of three (3) years beginning on the **July 1, 2024**, and ending on the **July 1, 2027**, at midnight, unless sooner terminated as provided in the Student Teacher Agreement.
3. This Renewal Agreement modifies the Student Teacher Agreement as herein set out, but not otherwise.


