MINUTES OF THE MEETING COLLEGE OF EDUCATION EXECUTIVE COMMITTEE

The College of Education Executive Committee met on Thursday, March 12, 2009, at 8:30 a.m. in Room 235 of the Education Center with Dean Gunter presiding. Members present were: Lee, Gerber, Roberts, Reffel, Martinez, Leech, Myers-Jennings, Minor, Griffin, Bauer, Stanley, Pearce, Corbin, Gladwin, and Hull. Guests included James Ernest and Interim Graduate Dean Karla Hull.

Minutes of February 26, 2009 Meeting --- Reffel

A motion by Reffel was made to approve the minutes from the Executive Committee meeting on February 26. There was no discussion, the motion carried and the minutes were approved.

GAs/TAs --- K. Hull

Interim Dean Hull presented updated information on Graduate Assistantships. When President Schloss encouraged Deans to create "Super Sections" (25) were created, with Graduate Assistants to be assigned. Dr. Hull presented to the Deans' council moving Graduate Assistantships from some small programs into "Super Sections." GOML programs have grown at VSU and revenue exists. One proposal is to fund Graduate Assistants in the College of Education out of GOML funds. It is proposed that GOML Graduate Assistants be able to earn more money. Graduate Assistants are to be used for more scholarly activities (ie. Supporting faculty to do research, working with Program data). They will be trained in library research and Vista8 prior to being assigned to departments. Departments will be asked to write a job description (title, basic type of assistantship—Teaching Assistants for "Super Sections"; Graduate Assistants; and Graduate Research Assistants)

Report from President's Cabinet of February 26 --- Gunter

Dean Gunter presented the information about the Conference Call on the Stimulus package to be held today. Other information from the President's Cabinet meeting included the upcoming Gala. Seven representatives will be at the Gala for the Dewar College of Education.

Report from Dean's Council of March 4 --- Gunter

Dean Gunter presented information from the March 4 Dean's Council. Topics discussed included GA/TAs; the new e-rate of \$225 for graduate and \$189 for undergraduate courses (beginning fall 2009); on-line Graduate catalog; and progress towards the SACS visit. Dr. Levy wanted recommendations for the University tenure and promotion committee. Finally, it was discussed that individuals with PCards should be the doing ordering.

Report form RESA Board of Control meeting of March 5 --- Gunter/Gerber

Dean Gunter shared about the RESA Board of Control Meeting. The GADOE hosted a webinar held by Cathy Cox about the stimulus funds directed to Title I. Title I and IDEA funds are to be doubled, but open for many activities. ETTC will probably be moved to the RESAs. Higher Education will receive \$108 million in 2010. Dr. Gerber added that the superintendents were reminded that the Title I monies will be temporary, and not designed to sustain new projects, and accounting will be very transparent.

A revision of the Early Childhood Special Education General Curriculum program was presented in LiveText to the Executive Committee at the end of last week.
