B.S.Ed. in American Sign Language/English Interpreting

The Bachelor of Science in Education degree in American Sign Language/English Interpreting is a rigorous program that prepares students to work as professional interpreters, ensuring communication access in a variety of settings wherever hearing and D/deaf or hard of hearing people come together. Our graduates go on to work in K-12 and post-secondary public educational settings, as well as other community, freelance, and staff interpreting positions. Valdosta State University is one of two universities in Georgia to offer a Bachelor's Degree in American Sign Language Interpreting. Because of a critical shortage of American Sign Language interpreters, students in the Valdosta State program are in high demand. The degree program may be completed via distance learning or on campus, where classes average approximately 15 students. Students gain hands-on experience by participating in fieldwork, service learning, and internships.



Frequently Asked Questions



1. Do I have to know sign language before I enroll?

No. Coursework in American Sign Language is part of the major core and program.

2. Is the program completed online?

No. Some of our courses (ASLS 3190, for example) are online only courses, but most of the coursework is completed in face to face classes or videoconferencing technology that allows you to attend classes remotely at the same times as the onsite students.

3. Will I be a certified interpreter when I complete this degree?

That depends on your level of proficiency, but usually not. This program, like almost all undergraduate interpreting programs, prepares you for entry-level work in the field. National Interpreter Certification is usually attained after a few years of experience working as an interpreter.

The state of Georgia requires licensure for interpreters working in K-12 schools. In order to obtain a license, you must have National Interpreter Certification or have a 3.5 or better on the Educational Interpreter Performance Assessment. Many of our graduates achieve a 3.5 or higher upon program completion. This, in combination with the earned Bachelor's Degree would make them eligible for a clear, renewable Georgia Educational Interpreting License.

4. Does this degree certify me to teach ASL?

No. Program coursework prepares you for work as an interpreter, but does not teach you how to teach. For more information on Georgia Teacher Certification in ASL, see the Georgia Professional Standards commission website for pathways to ASL Certification.

5. I don't want to earn a degree; can I just take ASL classes?

Our courses are offered to degree-seeking students enrolled at Valdosta State University. Contact Continuing Education for more information on community ASL course Offerings.

6. I am happy with my major, but want to take ASL courses-can I?

Yes! When seats are available, non-major students are permitted to enroll in ASL courses. We also offer a minor in Deaf Studies which includes the four ASL courses and two additional culture/education courses.

7. Can I transfer credit from another institution into the program?

Your first step is to apply to admission to VSU. Your transcript will be evaluated and an advisor will contact you letting you know for which courses you received credit and which remaining courses you need to complete. A minimum of 30 credit hours must be completed at Valdosta State University in order for the degree to be awarded.

8. What is the minimum GPA required for program entry?

Students must have a 2.75 cumulative GPA in order to be admitted to the program.
