edTPA Update: Ms. Fuller discussed MGED and everyone getting on board. She will be providing information to those who have not been in the meetings and it will be organized and put in binders this way everyone has the same information she has. Everyone who is involved in teaching a program for initial certification will have this information. She has provided a CD which was put in everyone's box and also access to a dropbox. These two things were from workshops and will provide you with some information about how other institutions have approached edTPA. Also, there is some training at Columbus State on April 11<sup>th</sup>. This next Fall 2014-2015 we will be on full implementation with every student teacher in the College of Ed will be on board with edTPA for Fall and Spring of this coming year. They aren't as prepared as they and need to be taught in the course work. In 2015-2016 there will be consequences from the State, as in I graduate with my degree, I have my two GACE tests and I also need to be satisfactory with edTPA to earn my certificate. So we have some time but not a lot. Dr. Paine is having us work on in this in the middle grades program where are the students going to learn these skills in the classes they are taking. Deaf Ed is also been working in that same format. They have to be prepared by the time they get to student teaching. It is a rigorous assignment. We also need to get MAT on board to see what it will look in those classes so we can get everyone prepared.

We also have three middle grade students who are piloting this semester. We chose all Language Arts. Dr. Radcliffe, Dr. Paine and I are mentoring these three so we can force ourselves to get more familiar with it. We handpicked these students and we were very smart about and simple. The focus just has to be a little different; it has to be in the program before the student teaching.

**TCKES:** Is the VSU version for teacher candidates of what the public schools in Georgia are using to evaluate their teachers that are employed. Basically we are piloting this semester and we chose by Supervisor so Ms. Fuller, Ms. Caldwell and Dr. Spires are the ones who are piloting. It is more a totality of evidence type instrument. As a supervisor we are just getting snapshots of their performance. We have got to decide how we can have candidates prepared to know that this will be your job in the state of Georgia and be able to do these things. But we aren't there quite as often and we don't have the DOE portal available to us. We are trying to target certain observable behaviors that would be accurate as well as talking with the mentor

teacher about the things we don't observe. You have to ask those questions are they doing certain things that are expected from them.

# **Program Updates:**

**ASL/INTP** – Williams

**DEAF** – Scheetz – modifying charts from edTPA that Dr. Paine has provided.

**EDAT** – Lennon collaborative to meet in March for two days. Hope to get 6000 rolled out for summer.

**MAT/MSED** – Spires/Cox – Working to get ready for changes.

**MGMS** – Need to reexamine the program and requirement of the courses due to conflicts with UNG students. Also spoke to Ms. Moody about live text since we don't have access to their students.

**READ** – Dr. Dixey states all approvals have been obtained. It is ready to go to the catalog and now we want to get permission to put it online. Since the University already has courses online and has that approval, we just need a vote to put it online. It will be a regular online Masters of Reading. We hope this will increase our enrollment. There has been some approval for travel for face to face with some of the students who have been in through the program. Dr. Radcliffe will take it to the Executive Council.

**EDET** – Dr. Martin reported that last summer began the transition for the first students that were in teacher leadership which was the awesome beginning of the clinical residency. So the students who started there were in 8001, in the Fall 8002, now this Spring in 8003 also every semester we started a new group of 8001's and it has grown. We saw a real dip when we transitioned to teacher leadership. I blame most of that on Professional Standards Commission which gave out false information. We are building back up now. We have two classes of clinical residencies in the Fall and Spring. Those who are finishing their clinical residencies this semester and I have this group, their requirement is that they design, implement and assess the effectiveness of an ongoing professional development in their school. They do this in collaboration with an administrator. The projects from 8001, 8002, and 8003 are really powerful to see these teachers now develop into real teacher leaders where they are conducting professional development.

**GOML** enrollment has dropped significantly. We are our own advocates and we need to actively pursue graduates and get quality students.
