Can you see your future self as a registered dental hygienist? Would you like to enter a dental hygiene program that has 100% pass rates for licensure year after year? Would you like to learn in a setting with small class sizes and lots of individualized instruction? If you said YES to all questions, the cooperative dental hygiene program offered by Valdosta State University and Wiregrass Georgia Technical College is the program for you!

This packet provides important information regarding required courses, admission procedures, estimated expenses, shadowing requirements and the competitive application process.

The program is accredited by the Commission on Dental Accreditation (CODA). Upon successful completion of the program, the student is awarded an A.A.S. degree and is eligible to sit for clinical and national licensing examinations.

Dental Hygiene clinical training is 5 semesters in length. (This includes a summer session.) A new cohort begins clinical training fall semester each year. All Dental Hygiene classes are taught on the Wiregrass Valdosta Campus located at 4089 Val Tech Road, Valdosta, GA, 31602.

Enrollment is limited and admission is competitive. Only 15 open positions are awarded each year. Admission to Valdosta State and/or Wiregrass Georgia Technical College does not guarantee admission to the Dental Hygiene clinical training program. The competitive admission application portal opens each year on February 1st.

This admissions packet has been designed to answer common questions regarding the cooperative Dental Hygiene program. Please read the packet in its entirety. Curriculum Current Beginning Fall 2025

Important, Must Know Program Information

Cooperative Program Enrollment: Accepted students will be dually enrolled at VSU and WGTC during clinical training. Students must be enrolled and in good academic standing at both institutions upon application, acceptance, program entry and for the duration of clinical training

Advisement and Timeline for Requirements: A "Timeline for a Successful Dental Hygiene Candidate" is provided during advisement. Follow the timeline carefully! Requirements are subject to change. At times, changes to requirements, deadlines and equipment are necessary to meet current curriculum and accreditation specifications. Changes will be communicated via the updated packet on the WGTC and VSU websites. It is the responsibility of the student to download and follow the current packet guidelines.

Competitive Admission Program: Acceptance to the clinical dental hygiene program is competitive. Fifteen (15) seats are available each year. The competitive admission application is open annually February 1- March 1. Link is located on WGTC dental hygiene webpage. Students must be accepted to both institutions (Wiregrass and Valdosta State) to submit application for competitive admission.

Program Informational Sessions: Two informational sessions are held each year. Standing dates are the last Tuesday in September and last Tuesday in January. See the dental hygiene webpage for specific times and locations. While this session IS NOT MANDATORY, students are advised to attend at least 1 session.

Mandatory Program Orientation: Required for Accepted Candidates. The orientation is held annually in early June. Family and friends are welcome to attend this meeting with the accepted students. Specific Date and time for the mandatory orientation will be announced with the program acceptance letter/e-mail. The orientation is held in Mark Hall on the Wiregrass Campus in the Dental Department.

Financial Aid: All tuition and fees are paid directly to Valdosta State University during clinical training. Students will request all financial aid (FAFSA, HOPE, PELL, Etc.) through Valdosta State University.

Out of Pocket Expenses: Dental Hygiene students will have out-of-pocket equipment expenses that will not be covered by financial aid. A list of the estimated expenses is in this packet. Specific instructions for purchases will be provided at orientation. Do not attempt to purchase equipment on your own. Do not purchase used equipment.

Medical Testing Requirements: Medical requirements will include but are not limited to oral health exam, current eye exam, Tuberculin skin test, up-to-date immunizations, mandatory vaccinations, and/or titers. Specific instructions and requirements will be provided at the program orientation for accepted students.

Chair Occupancy: During clinical experiences, students are responsible for chair occupancy. Students must recruit patients to meet clinical requirements for graduation.

Competitive Entry Criteria

Program Specific Criteria: The competitive admissions process is based on specific academic criteria, including prerequisite courses and HESI A2 scores and shadowing. Students must submit an online competitive admissions application, official transcripts, HESI A2 scores.

Shadowing Requirements: Shadowing verification must be submitted with the competitive entry application specific shadowing requirements are described on the next page.

Enrollment at VSU and Wiregrass: All applicants must be accepted as a student at both Wiregrass Georgia Technical College and Valdosta State University. All applicants (including transfer students) must be accepted to BOTH institutions prior to beginning competitive entry application process February 1st. Institutional acceptance to VSU and/or WGTC does not guarantee admission to the clinical Dental Hygiene Program.

Advisement Prior to Application: All applicants (including transfer students) must be advised by VSU advisors prior to February 1st.

Academic Standing: Applicants must be in good academic standing at both WGTC and VSU at the time of application, upon program entry, and for the duration of clinical training. Students on academic warning, probation, or suspension will not be considered in the competitive admissions process.

Application Period: Annually February 1st - March 1st for Fall semester entry.

Incomplete and/or in progress Prerequisite Courses: It is permitted to submit competitive admissions applications with incomplete and/or in progress prerequisite courses. Students will only receive quality points for complete courses. Priority may be given to core complete students.

Completion of Pre-Requisite Courses: All required prerequisites must be completed prior to program entry fall semester. If an applicant is offered a seat but fails to successfully complete a prerequisite course, that seat will be revoked and offered to the next qualifying candidate. The highest course attempt will be calculated for competitive admission. Prerequisite science courses must be completed within 10 years from the start of the program.

Class Capacity is 15 Students: Following the application deadline, if class capacity remains unfilled, the deadlines and/or other requirements can be extended or modified with the approval of the Dean of Health Sciences.

GPA Requirements

- Minimum program GPA of 2.5 is required for program entry and graduation.
- All prerequisite courses must be completed with a "C" or better.

HESI A2 Exam Requirements

- A cumulative score of **75%** is required on the HESI A2 exam.
- Required sections include Reading Comprehension, Vocabulary, Grammar, Anatomy & Physiology, Math and Critical Thinking
- A maximum of three (3) attempts will be allowed in a two (2) year period. Scores are valid for 2 years.
- The HESI A2 exam may be taken at the VSU or Wiregrass Testing Center.

Dental Hygiene Shadowing Requirements

- **Shadowing Type 1: Shadowing the Dental Hygienist (12 hours in 2 offices)**
 - The applicant must shadow multiple hygienists in multiple dental offices. (Multiple means 2 or more)
 - A minimum of 12 hours will be required.
 - The 12 hours must be divided between multiple (2 or more) dental offices. (6 & 6, 3 & 9, 4 & 8, etc.)
 - Dental office shadowing should be completed as early as possible. Shadowing documentation **MUST** be submitted with the application prior to the March 1st deadline. Do not wait until the last minute!
 - Note that prior experience working in a dental office does not satisfy this shadowing requirement.
 - Applicant is responsible for identifying suitable dental offices for shadowing.
 - **Shadowing Type 2: Shadowing in the Wiregrass Student Clinic on the Valdosta Campus (1 session)**
 - Applicants will observe a senior dental hygiene student for 1 clinical session.
 - Clinical observation sessions are scheduled in advance and available by appointment only.
 - Wiregrass student clinic shadowing should be completed as early as possible. Shadowing documentation **MUST** be submitted with the application prior to the March 1st deadline. Do not wait until the last minute!
- Both** Shadowing Types are Required. Shadowing hours DO NOT expire. Shadowing form located in this packet.

Bonus Points

Five bonus points can be awarded for prior completion of a CODA accredited dental assisting program. Documentation must be provided to the Director of Dental Programs for approval PRIOR to February 1st.

All competitive admissions criteria are current at the time of this publication.

Criteria may be modified as necessary for compliance with accreditation requirements or curriculum revisions.

It is the responsibility of the student to be aware of current requirements, deadlines and criteria.

Students will be notified of changes via updates to this informational packet.

Current informational packet will be available on the Wiregrass and VSU Dental Hygiene web page.

Deadlines and Instructions for Application to Dental Hygiene Program

Application is open annually from February 1st to March 1st for Fall entry.

Applications with missing documentation after March 1st will not be considered for program admission.

1. Each student must be advised by a dental hygiene advisor in the CONHS at VSU prior to February 1st.
2. When applying to Valdosta State University, declare your major as Dental Hygiene.
When applying to Wiregrass, declare your major as a Technical Specialist (TCC). (The 15 accepted students will have majors changed to DHYG prior to program admission.)
3. Submit your application for competitive admission between Feb 1st- March 1st. **The link for the application portal will be located on the Wiregrass Dental Hygiene webpage.**
4. The following documentation will be required to successfully complete the application.
 - VSU student ID number and email address
 - Wiregrass student ID number and email address
 - Transcripts from all institutions that you attended.
 - You may submit an unofficial transcript with the application
 - OFFICIAL TRANSCRIPTS must be received by Wiregrass and VSU admissions office prior March 31st
 - HESI A2 Exam Scores (All attempts)
 - Completed and signed Shadowing Form
5. Applicants will be notified of acceptance status within 6-8 weeks following the March 31st deadline. Notifications will include instructions for next steps and will be sent via Wiregrass e-mail. Check your Wiregrass e-mail regularly!
6. Nonaccepted applicants will be waitlisted in rank order. Waitlisted students will be offered a seat in the class if one becomes available. If you are not accepted in the current year, see your advisor for next steps.
7. Questions regarding application for competitive admission should be directed to the Admissions Office at Wiregrass Georgia Technical College.

Estimated Out-of-Pocket Expenses for the Dental Hygiene Clinical Training Program

- **Dental hygiene students will have out-of-pocket expenses that will not be covered by financial aid.**
- Estimated expenses described in this list **Do Not** include fees and tuition paid directly to VSU. VSU bursary can provide estimated costs for tuition and fees for each semester. No tuition or fees will be paid to Wiregrass.
- Dental hygiene students must make financial arrangements to purchase supplies and equipment prior to program entry.
- Students will not be able to wait for financial aid disbursements for equipment purchases.
- This list of estimated supplies, equipment, and expenses is provided prior to program application and entry. All potential students are aware of the financial responsibilities related to the dental hygiene clinical training program.
- Equipment and costs are current at the time list is published. Estimates do not include shipping or taxes.
- Requirements, cost of equipment, purchase deadlines and vendors are subject to change without notice to meet curriculum and accreditation requirements.
- All specified supplies and equipment must be purchased **on or before the 1st day of each semester.**
- Students will be required to present equipment or valid proof of purchase to dental hygiene faculty for verification.
- The semester for which a particular item will be purchased is subject to change based on needs of the curriculum.

MISC Program Requirements

- An internet capable device and internet access will be necessary each semester.
- Students are responsible for reliable transportation to and from the Wiregrass campus for the duration of clinical training.
- Students are responsible for maintaining seat occupancy to meet clinical requirements and progress towards graduation.

Penalty for Failure to Purchase Equipment on or Before 1st Day of Semester

New Student: Failure to purchase equipment on or before the 1st day of the semester will result in forfeiture of a student's seat in the class to an eligible waitlisted dental hygiene candidate. Faculty will verify all equipment and/or proof of purchase on the first day of the semester. Instructions for equipment purchases will be provided prior to program entry at the mandatory accepted student orientation in June.

Returning Student: Failure to purchase equipment on or before the 1st day of class will result in the student being sent home and marked absent from all DHYG classes until all specified equipment has been purchased and verified. Departmental attendance policy will apply to absences. Students are provided with specific purchasing instructions at least 2 weeks prior to the end of each semester.

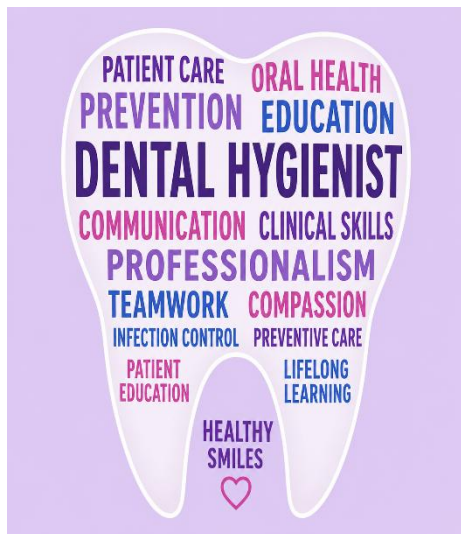
Dental Hygiene Career Paths

Working in a private dental office continues to be the primary place of employment for dental hygienists. However, for today's dental hygiene professionals, there are many other career pathways to explore as well. Examples include dental hygienists in corporate dental settings, public health and community health program hygienists, dental researchers and dental educators.

Program Goals

1. Provide quality industry driven education and training that prepares dental hygiene students to enter the work force as critically thinking dental healthcare professionals.
