ESOL Endorsement:

- Problem: students are struggling to classify themselves as endorsement or non-endorsement students
- Next Semester:
 - Dr. Ocasio's class can be removed from the Qualtrics Survey
 - Dr. Gladwin and Dr. Bejarano to pull out all MCL MAT (FLED & ESOL) students.
 - All non MCL MAT students will be asked to take the Qualtrics survey to confirm if endorsement or non-endorsement track
 - If students answer that they "do not know" if they are endorsement or not, they will be prompted to confirm their status with their adviser
